As the 2006-2007 President of the Manitoba Dental Hygienists' Association I welcome you to this new year. This is a deja-vu moment for me since I sat in this chair before as I was President of the MDHA in 1987. I have held numerous positions with the MDHA over the years including: secretary, auxiliary legislation rep, Manitoba Dental Association Auxiliary Committee Member, representative to the MDA, representative to the Dental Professions Act Working Group for the Government of Manitoba, member of the legislation committee, representative to the Provincial Council of Women, and Provincial Director of the Canadian Dental Hygienists Association. By this time next year we hope that the College of Dental Hygienists of Manitoba (CDHM) will be our legal regulatory body. The CDHM will be mandated by the Government of Government of Manitoba to register and license all practicing dental hygienists practice in accordance with their accepted scope of practice, guaranteeing that the public receives care from a competent dental hygienist. The Manitoba Dental Hygienists' Association will remain the professional association representing the dental hygienists of Manitoba. With the attainment of professional self-regulation, comes a new responsibility for our organization as we will now become an important player in the health policy community of Manitoba. Now, more than ever, we must have a strong voice and vision in order to gain the respect of others within the health policy community. It is the mandate of the MDHA "to cultivate, promote, and sustain the art and science of dental hygiene, to represent, maintain, and safeguard the honour and communication, unity, and social intercourse among its members, and to contribute toward the education and improvement of the health of the public". These objectives were part of the revised constitution of the MDHA in 1988 and remain our objectives today.

To meet these objectives the MDHA must have a solid foundation with communication being one of its strongest pillars. We must be able to listen to, and understand what is important to our members, and be able to communicate information that will support the profession and practice of dental hygiene with both, our members and the public. We must be active in our community and foster relationships with other health professionals and the public, to ensure that Manitobans are receiving the best health care possible. Without strong internal communication with our members, it will be difficult to project a strong external image to the public and to policy makers.

As your President for this current term my personal goal for the association is to build a strong line of communication. Legislation Committee Update

MDHA's Legislation Committee is busy at work helping to support the efforts of the Transitional Council (TC) of the College of Dental Hygienists of Manitoba (CDHM). In June 2006 the TC began and subcommittees have been busy all summer, and a meeting is planned for Sept 13th. At this meeting draft regulations and by-laws, the application form for registering dental hygienists and job descriptions for the registrar and other key individuals will be discussed.

OPPORTUNITIES

Registrar: 1 dental hygienist who is a part-time CDHM employee

Registers dental hygienists

Member of Council: 6 dental hygienists, 3 public representatives

Manages the business and affairs of the CDHM

Member of Board of Assessors: 3 dental hygienists

Reviews/approves applications for registering to practice

Member of Complaints Committee: 2 dental hygienists, 1 public representative

Reviews complaints made regarding a dental hygienist; makes decisions regarding the handling of a complaint, including monitoring or placing conditions on the member's practice.

<u>Member of Inquiry Committee</u>: 2 dental hygienists, 1 public representative Conducts hearings regarding complaints referred on by the Complaints

Committee

<u>Member of Continuing Competency Committee</u>: will oversee quality assurance/continuing competency program

QUESTIONS & ANSWERS

Dental hygienists continue to contact MDHA with questions regarding what will be happening when the CDHM is in effect.

When will dental hygienists be able to work without the dentist in the office?

This is a question asked by both dental hygienists and dentists. As regulations and by-laws are still in the development stages, the Transitional Council anticipates that the MDA will continue to register dental hygienists for 2007. As the MDA requires direct supervision, we

anticipate this will continue until regulatory responsibility is passed to the CDHM. The actual details of scope of practice and supervision will soon be under discussion by the Transitional Council. Until things get further along, it is hard to predict when the CDHM will first register dental hygienists; however, in this regard MDHA's goal continues to be increasing access to care by the removal of restrictive supervision.

I have not taken the National Dental Hygiene Board (NDHCB) Exam, but would like to practice in Manitoba. Will I need to take it?

If you are currently a dental hygienist licensed to practice in Manitoba, in all likelihood you will upon completing an application form and paying the registration fee be grandparented directly into the College of Dental Hygienists of Manitoba. Once the CDHM is in effect, however, it is anticipated that new graduates and graduates from other provinces will be required to have the NDHCB Exam.

Teaching Opportunity

Legislation Committee Update

Once I am registered in Manitoba under the CDHM, would I be able to practice anywhere else in Canada?

There is an attempt on the part of regulatory bodies to recognize credentials from other provinces if the individual is in good standing and has met the province of origin's requirements for registration. However, the province in which the applicant would like to register does have the responsibility for ensuring that the public is protected, and therefore that the applicant is competent. It is in the applicant's best interests to directly contact the province they would like to practice in to ensure that they meet its requirements.

We hope this has been helpful. Please submit any questions you may have to the Legislation Committee and we will be happy to address them to the best of our ability.

MDA Graduates Pilot Class of Preventive Dentistry Scaling Module for Dental Assistants

History

In March 2004, the MDA directed the Oral Health Team Committee to investigate the addition of scaling procedures for dental assistants. The Oral Health Team Committee, with MDHA representation, developed recommendations for a Pilot Module that was presented to the MDA Board. Based on those recommendations, the MDA Board approved the development of a Preventive Dentistry Scaling Module for Dental Assistants. A Task Force was struck with representation from key stakeholders including the MDHA. After the first meeting of the Task Force, the MDHA representative requested that a decision be made by the Association whether to continue its participation. At the Annual Mid-Winter meeting of the MDHA, a motion was made and supported by the membership to withdraw representation from the Task Force due to a direct juxtaposition of MDHA's mission. The School of Dental Hygiene, the Faculty of Dentistry, and a representative of the Manitoba Society of Periodontists remained on the Task Force along with other members representing urban and rural dentists, dental assistants, and dental assisting educators. Throughout the winter of 2005, the Task Force met to develop reasonable criteria for this proposal. Task Force recommendations were sent to the MDA Board for consideration at which time the Task Force was disbanded. The MDA Board then struck another Board Sub-Committee to review the Task Force recommendations. The resulting revision was substantially altered to include periodontal probing and subgingival debridement to 2mm.

In January of 2006, the MDHA invited the MDA President (Lee McFadden) and our Representative to the MDA Board (Mary Ann Marks Level II DA) to update our membership at our Annual Mid-Winter meeting on the progress of the scaling module. Both requests were declined. The newly appointed Preventive Dentistry Scaling Module Selection Committee of the MDA awarded CDI College the tender to pilot the program at its January 26, 2006 Board Meeting. In March 2006, sixteen level 2 dental assistants with a minimum of 3years experience within the last 5 years were selected to begin the pilot. The course was comprised of a six week home study component followed by a part-time evening and weekend clinical component spanning a two month period. Fifteen students successfully completed the program and were able to apply their skills as of July 17, 2006.

Scope of Practice

In addition to their Level II duties, the Preventive Dentistry Scaling Assistant is able to practice the following under the Direct Supervision of a licensed Dentist:

- Use the explorer, periodontal probe, air, light and transillumination to locate and detect calculus deposits to 2mm subgingivally
- Use anterior and posterior sickle scalers and universal curettes to remove coronal stains, calculus, and plaque to 2mm subgingivally
- Sharpen scalers and universal curettes
- Identify and solve instrumentation problems

Evaluation

The selection committee will perform a full evaluation of the pilot program with the report presented to the MDA Board at its October 14th 2006 meeting.
